# General terms and conditions valid upon conclusion of the contract

# Registration

ürisee-Kinderbetreuung

Admission is regardless of nationality, skin color, denomination or social status. The admission of the child becomes definite as soon as the contract has been signed by the KiTa management and the parents and the deposit, amounting to a monthly sum, has been paid. Parents who receive subsidies from the municipality are exempt from paying a deposit, provided that the municipality transfers the monthly sum directly to us.

# Regular care

The days of care are determined when the contract is signed. They are the same every week or every month and are firmly booked. A possible wish to change (switches and extensions) of the care days will be complied with, if possible. Provided that the necessary care capacity is available. The reduction of the agreed days of care is subject to a two-month notice period.

#### Periods of notice

Each KiTa-spot can be terminated at the end of every month by the parents and the Zürisee - Krippe with a two-month notice period in writing. If a spot has been contractually agreed upon and the parent cancels the contract prior to the start of the acclimatization period, a one-time fee amounting to one month's fee will be charged. If the deposit has already been paid, it will be retained for the expenses and no further invoice will be issued.

#### Vacation/Holiday Care

Extended vacation care must be requested at least 10 days before the vacation in order to ensure optimal staff planning. The vacation care must be requested with the correct form provided by us and be approved by our administrative or pedagogical management. If the form is signed by both parties, it is considered a short-term contract and the costs for the vacation care are to be paid, even if the child is not brought to the vacation care.

# Care in case of illness

The Zürisee nursery is not equipped to care for sick children. The nursery management decides on a case-by-case basis whether to admit a child who is slightly ill. The exact conditions can be found in the leaflet: "My sick child and the nursery".



#### **Data Protection Act**

Due to the new data protection law we are obliged to ask the legal guardian for a signature. We work on several computers/laptops at the same time and in different locations. For this, we use cloud services such as dropbox and ondrive. Since these are foreign cloud services, without your signature, we violate the new DPA, Art 4 Abs 4 and Art 6.

It is mainly about a document that is on dropbox/ ondrive and is always being updatedthis document is a parents and children's list, which we have to keep for the KESB. New parents are added with contact details, terminations are noted.
